# **2020 MAPLETON TOWN MEETING MINUTES**

At 3:00 pm Susan Skidgell opened the Meeting by reading the following statement:

#### **GREETINGS**:

In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of the Town of Mapleton, in said county, qualified by law to vote in Town affairs, to meet at the Mapleton Lions Hall, in said Town, on Monday, the 16<sup>th</sup> day of March, A.D. 2020, at three o'clock in the afternoon and then and there to act upon Articles 1 through 3 by ballot as set out below, the polling hours therefore to be from three o'clock in the afternoon until seven o'clock in the evening;

True attested copies of the warrant were posted at the Mapleton – Castle Hill – Chapman town office, Mapleton One Stop and the Post office. All being public and conspicuous places for the Town of Mapleton.

Art. 1 To elect by majority on written ballot, a moderator to preside at said meeting.

At 3:00 pm Bonnie Steeves nominated Penny Kennedy as Moderator with Nadiene Brewer seconding the motion. No further nominations were made. Skidgell asked for at least three written ballots to be cast. 3 ballots were cast. After the voting ceased, the ballots were counted. All the ballots were for Penny Kennedy. Kennedy opened the polls and read Article 2and 3.

**Art. 2** To elect *by majority on secret ballot*, according to the provisions of the Revised Statutes of Maine, Title 30-A, Section 2528: One (1) Select Board Member for a term of three (3) years; One (1) Assessor for a term of three (3) years; and One (1) Sewer District Trustee for a term of three (3) years.

**Art. 3** To vote *by majority on secret ballot*, "Shall the Town of Mapleton authorize the State to permit the operation of agency liquor stores on days other than Sunday?".(MRSA Title 28-A§123.2)

At 7:00 pm Kennedy swore in Wesley Lavigne as Deputy Moderator. Lavigne read the following articles and asked for action from the audience of 14 residents.

Art. 4 To see if the Town will authorize the municipal officers to choose all necessary municipal officials for the ensuing year.

**Art. 19** To see if the Town will vote to authorize the municipal officers to appropriate all interest earned or capital gains realized on Reserve Accounts as Interest Earned Revenue. **SELECTMEN RECOMMEND: Approval**

**Art. 20** To see if the Town will vote to appropriate all revenues from recreation fees to reduce recreation expenses and to place any remaining fundraising revenues into the recreation reserve account, according to the Interlocal Agreement. **SELECTMEN RECOMMEND: Approval**

This will allow the Town to operate during the 3 months prior to the annual town meeting. **SELECTMEN RECOMMEND: Approval**

**Art. 23** To see if the Town will vote to authorize the municipal officers to expend funds from the Local Road Improvement reserve account in the best interest of the Town, when proper funds are available.

Motion passed by a show of hands **Art. 26** To see if the Town will vote to authorize the municipal officers to sell any outdated capital equipment on such terms as they deem advisable and place such funds in the equipment reserve fund, according to the Interlocal Agreement.

**Art. 27** To see if the Town will vote to authorize the municipal officers, on behalf of the Town, to sell and dispose of any real estate, however acquired, on such terms as they deem advisable, to execute a municipal quit claim deed without covenants on such property, and to lease property and sell stumpage on such terms as they deem advisable. Real estate sales shall be offered by sealed bid after notice of sale has been advertised for two (2) consecutive weeks, unless the property is offered to the previous owner for accumulated taxes, interest, and other costs against said property, except that the Municipal Officers shall use the special sale process required by 36 M.R.S § 943-C for qualifying homestead property if they choose to sell it to anyone other than the former owner(s).

**Art. 28** To see if the Town will vote to authorize the municipal officers, on behalf of the Town, to apply for, accept and expend grant funds from state government agencies, federal government agencies, or private organizations, for any purpose they deem in the best interest of the Town. **SELECTMEN RECOMMEND: Approval** 

Motion to accept the Selectmen's Recommendation on Article 28 as written: Robert Bagley Second: David Maxcy No discussion. Motion passed by a show of hands

**Art. 29** To see if the Town will vote to authorize the municipal officers, on behalf of the Town, to accept gifts and real estate which may be given to the Town, and to accept funds from the State of Maine, the United States and from other identified sources, and to appropriate any funds received to specified or appropriate accounts or funds.

# **SELECTMEN RECOMMEND: Approval**

**Art. 30** To see if the Town will vote to authorize the municipal officers to execute contracts of terms three (3) years or less, for services deemed in the best interest of the Town. **SELECTMEN RECOMMEND: Approval** 

Motion to accept the Selectmen's Recommendation on Article 30 as written: Robert Bagley Second: David Maxcy No discussion. Motion passed by a show of hands

**Art. 31** To see if the Town, in accordance with the Revised Statutes of Maine, Title 36, Section 506, will authorize the tax collector and town treasurer to accept prepayment of taxes not yet committed and to pay no interest thereon.

# **SELECTMEN RECOMMEND: Approval**

Motion to accept the Selectmen's Recommendation on Article 31 as written: Robert Bagley

Lavigne announced the results of the election and are as follows:

Selectmen (3-year term) David Dunlavey 51 votes, Kim Archer 40 votes Assessor (3-year term) David Maxcy won by 7 write ins Sewer District Trustee (3- year term) Amos Dean 50 votes and Jeffrey Cray 38 votes

Article 3 passed 76 yes to 19 no

No further business was discussed. A motion to adjourn was made by Robert Bagley and seconded by David Maxcy.
