Weekly reports for the new Fire Truck are being sent to the Board. The new truck is expected in early 2023. The Federal Emergency Management Association awarded a grant to the Fire Department for a generator. The generator will be installed at the dispatch communication tower. There have been several grants submitted this month. The Town Manager will be on vacation out of the country from July 16<sup>th</sup> – July 24<sup>th</sup> returning to work on July 25<sup>th</sup>. Chris and Lisa will be in charge during this time. The Financial Reports and Code Enforcement Officer reports were presented.
